You are required to provide us with certain personal data when you receive our Services. Personal data that is mandatory is indicated in the relevant forms. We are not able to provide our Services to you if such data is not provided.

3. How we use your personal data

We use personal data for the following purposes:

(1) Personal information concerning customers

- To make responses to inquiries and consultations received from customers
- To ship catalogs, goods, etc. and carry out related business activities
- To manufacture goods, engage in rental business, or provide services such as desi gning of contracted work, construction work or temporary facility work, and trans portation services
- To provide information concerning the Takamiya Group's goods and services
- To provide after-sales services and support in relation to goods and services
- To conduct billing or refunds, etc. of purchase prices and carry out related admin istrative work
- To improve the quality of telephone responses and prevent problems

(2) Personal information concerning business partners

- To carry out other administrative work in relation to the performance of agreeme nts
- To improve the quality of telephone responses and prevent problems
- To conduct surveys, questionnaire analyses and marketing activities for the develo pment of products and improvement of services
- To carry out administrative work of preparing payment records, etc. that are to b e prepared in accordance with the laws and regulations
- To otherwise process administrative work to properly and smoothly perform transa ctions with business partners

We process your personal data in the following cases in accordance with applicable laws and regulations:

We do not make decisions that may affect you legally or in a similarly significant manner based solely on automated processing.

4. How we share your personal data

We may share your personal data with the following recipients:

- (b) Our service providers that provide services on our behalf, such as tech vendors who support our websites and other business systems, operational companies such as delivery couriers, and payment services providers who help us process your payments. Our service providers are located in Japan, Vietnam, Korea and the Philippines.

5. International data transfers

The third parties to which we transfer your personal data in order to provide our services (please see "How we share your personal data" above), are located in Japan, Vietnam, Korea and the Philippines. Japan and Korea is recognized by the European Commission as providing an adequate level of data protection. Our data transfers to Vietnam and the Philippines are subject to standard data protection clauses adopted by the EU Commission under Article 46 Paragraph 2 of the GDPR.

6. Data retention

We retain your personal data for a period of three months maximum after your account is deleted, except where legal requirements imposing that we keep your personal data longer or less longer apply.

7. Your rights

Under the GDPR you have the right to ask us: for a copy of your personal data; to correct or delete your personal data; to restrict (stop any active) processing of your personal data; and to

send you a copy of your personal data you have provided to us in a structured, machine readable format. In addition, you can object to the processing of your personal data under certain conditions (for further information, see the section below entitled "Your right to object to processing"). Please note that these rights are subject to the exceptions under the GDPR and applicable local laws.

8. Your right to object to processing

10. Your right to complain to a supervisory authority
